Subject: Connect Transit LED Mobile Advertisements

The purpose of this memorandum is to inform the City Council about the attached request by Connect Transit to put lighted advertisements on the rear of their buses. Please see that request as Attachment 1.

The reason for this is that Connect Transit estimates conservatively that it will receive about \$250,000 per year in advertising revenue. The problem is that Bloomington currently has an ordinance prohibiting such signs. Please see the attached extract of the relevant ordinance as Attachment 2, and our proposed ordinance revision as Attachment 3. Normal has an ordinance addressing this but interprets it to not disallow this kind of advertising. The proposed advertising signs are a proprietary item from the Uberdisplay Company. Attachment 4 is an example of the sign they propose for our transit buses.

Connect Transit has met with Administration and Police and Fire from both the City and the Town. Staff's belief was that distracted driving was the purpose for the original prohibition. In light of current realities, however, and since these will only go on the rear of the Connect Transit buses, none of these concerns now rise to the point of being a strong objection.

Connect Transit suggests that such an amendment to the ordinance would allow them to proceed. The proposed change is very narrowly defined so as not to encourage a proliferation of moving lighted signs on other vehicles.

I recommend that staff bring forward such an ordinance change for Council's consideration.

Subject: Connect Transit LED Mobile Advertisements

Connect Transit started the advertising program in 2013 and it provides approximately \$130,000 in revenue. To increase our advertising revenue Connect desires to partner with Uber Displays, which could provide an additional \$250,000 in revenue. This is a conservative estimate and will provide Connect with much needed revenue.

Over the last six months we have met with Uber Display to discuss installing 2' x 4' LED signs on the rear of buses and display advertisements. Uber Display desires to partner with public transit agencies and is currently working with Nashville Metropolitan Transit Authority. At this time Uber Displays has no interest in partnering with public or private entities outside of transit agencies.

Each sign will display up to eight ads and the ads will change every eight seconds. Connect will still control what ads can be displayed through our advertising policy. Additionally, Uber Displays will provide free wifi to all of our buses that have the LED displays. Connect will also receive advertising revenue from wifi landing pages.

In addition to displaying ads on the LED displays, these will also have amber alerts and severe weather warnings. This will be beneficial to our customers, but also the community.

Connect Transit would greatly benefit to an amendment to the current ordinance to allow the LED displays to be installed on buses.

- 48. <u>PORTABLE SIGN</u>. Any sign not permanently attached to the ground or to a building or building surface.
- 22. <u>ELECTRIC SIG</u>N. Any sign activated or illuminated by means of electrical energy.

<u>SEC. 15.13-8 PROHIB TED SIG</u>NS. The following devices and locations shall be specifically prohibited:

D. Portable electric signs.

Section 6.9: Electrical Portable Signs

Use and display of electrical portable signs is prohibited, except when located on publicly funded, not-for-profit transit vehicles.
