CONSIDERED IN FEBRUARY

City Council Regular Agenda Items

- Consideration of a Resolution directing City staff to include funds in the amount of \$450,000 in the FY 2019 budget for intersection design, plans, construction documents, right-of-way, utility relocation, and construction for the intersection of Towanda Barnes Road and Ireland Grove Road, and authorizing the Interim City Manager or Mayor to enter into an amended intergovernmental agreement with the County on the intersection improvements, as requested by the Public Works Department. [Motion failed.]

 - a. Presentation of the Downtown East Washington Street Redevelopment Project

Approving an Ordinance to set a date for, and to approve a notice of a public hearing for the Downtown East Washington Street Redevelopment Project Area as recommended by the City's Community Development Department (The Redevelopment Project Area generally includes the East Washington Street Corridor bounded by North Gridley Street on the west and North Evans Street on the east including the former Bloomington High School building at 510 East Washington Street). - Consideration of an Ordinance approving a Contract to purchase the vacant property at 404 East Washington Street (the "Smith Property" which is adjacent to the City-owned former Coachman Motel property at 408 East Washington Street) for \$95,000.00 as recommended by the City's Community Development Department. [Motion carried.]
- Discussion and action on various proposed ordinances to amend Chapter 21 of the City Code regarding the City's residential solid waste program, including potential modification to the garbage rates and service levels, as requested at the City Council meeting on February 12, 2018. [Motion by Alderman Bray second by Alderman Mathy Council approves the Ordinance amending Chapter 21 of the City Code to enact provisions changing solid waste fees (i.e., a fee increase of \$4 per month for 95 gallon carts, \$4 per month for 65 gallon carts, and \$0 per month for 35 gallon carts and the low-income fee beginning May 1, 2018 and continual annual increases of 3% thereafter) and service levels to provide spring and fall bulk collection and bi-weekly brush collection be approved.] [Motion carried.]
- Presentation of Proposed Interim City Manager FY 2019 Budget [Presentation and discussion only.]
- Consideration of approving a Memorandum of Understanding with the Friends of the Bloomington Center for Performing Arts to establish, define, and coordinate a mutually

- beneficial relationship as requested by the Bloomington Center for the Performing Arts. (Item tabled to a Work Session or Committee of the Whole Meeting.)
- Consideration of a Resolution adopting the Twenty-Year Materials Recovery and Resource Management Plan for McLean County, Bloomington, and Normal, Illinois as requested by the Public Works Department. [Motion carried.]
- Discussion and action on an Ordinance implementing regulations on video gaming terminals and setting a one-year moratorium on the addition of new terminals within the City. [Motion carried.]
- Consideration of an Ordinance approving a petition from Macs Convenience Stores, for
 the approval of a Final Plat for Circle K Subdivision, (located south of General Electric
 Road, east of Hershey Road), subject to Tap On Fees being paid. [Motion by Alderman
 Painter second by Alderman Buragas recommend this item be sent back to the
 Planning Commission to refer the Final Plat for a legislative public hearing and require
 the submission of a Preliminary Plan, which was waived.] [Motion carried.]

COMMUNITY DEVELOPMENT

Building Safety

- There were a total of 472 Construction Permits issued in February of 2018, which is slightly down from the 508 Construction Permits issued in January of 2017. The value of the construction decreased from \$8,967,416 in the prior year 2017 to \$1,622,800 in January of 2018.
- No new projects were valued in excess of \$1,000,000.

Code Enforcement

 The Code Enforcement Division prepared the FOIA documentation regarding the background for 1110 Gettysburg Drive and other chronic violators for local media.

Planning, Zoning and Historic Preservation

- Staff continued work on the Zoning Ordinance update; the survey of historic properties along railway corridors, and preliminary coordination on Sign Ordinance update.
- The Planning Commission took action on approval of the Official 2017 Zoning Map.

- Three of Four ZBA cases were processed with two application approvals, one application denial and one tabled case.
- The HPC approved various Certificates of Appropriateness regarding historic plaque signage requests.

Economic Development

 Staff continued coordination of the East Washington Street TIF, among other on-going tasks.

Downtown Development (View January-February 2018 Report)

- Staff continues to provide support to the Bloomington Cultural Commission which is focusing efforts for development of a cultural district(s) and coordination of community events calendars.
- The February First Friday Event "The Tour De Chocolat" was a great success with approximately 800 participants enjoying activities in the downtown.



View Expanded Monthly Fire Statistics

- The number of incidents the department responded to was lower compared to January, some of this has to do with the fewer number of days in February, but overall it was a slower month.

- at 1101 Gettysburg Dr. This was a 12 unit apartment that resulted in \$650,000 damage. We also had 4 vehicle fires that resulted in \$10,800 in loss. Total fire loss for the month was \$681,200. The number of EMS call for the month was also down, we responded to 629 EMS calls for the month, this represented 77.75% of our calls for the month.

- Our fire investigators investigated 5 fires during the month of February, and put 34.9 man hours into these investigations.
- Our EMS personnel provided 60.5 hours of preceptor time to EMS students. BACC students had 66 hours of ride time with the department.

Golf Courses

- 183 rounds of outdoor golf were played at Prairie Vista. This is down considerably from our record
 of 995 rounds played last February. However, the rounds played for this month are still 40%
 higher than we see in a typical February.
- Inventory for the pro shops for the upcoming season has begun to arrive and staff is busy checking it all in and preparing it for sale.
- Titleist has chosen to renew their third season of 'Titleist Thursdays' at The Den at Fox Creek. 10
 weeks of tour level club fitting will take place each Thursday at the course bringing in golfers from
 all across Central Illinois. The Den is the only facility in Illinois south of Interstate 80 to serve as a
 host site for this program.
- Two of our golf course greens keepers successfully completed their recertification for the Illinois Applicator's License which is required to legally apply chemicals on the courses.
- The indoor golf simulator at Prairie Vista continues to do very well. During the month, 82 hours were booked in the simulator. This is up 64% from last February.

Miller Park Zoo I

- Revenue from admissions was down 9.9% for the current fiscal year. Last year, the revenue from
 admissions broke the all-time record for the Zoo in a fiscal year. This represents the sixth
 consecutive year the all-time attendance revenue record was broken. Attendance was down
 10.8% for the current fiscal year compared to last year's attendance. This represents the second
 consecutive year the all-time attendance record was broken. Revenue from Education Program
 Fees and Rentals was down .8% for the current fiscal year.
- Revenue from Concessions, Carousel, and Animal Food Sales was down 5.8% for the current fiscal year compared to last year's numbers. The Zootique sales were down .6% for the current fiscal year, and overall Zoo revenue was down 8.5%.

The original structure was open air and provided very little shade. The original pillars were salvaged and repaired prior to construction. Other items that were added are a new mulch surface, a custom made picnic table and a barbecue grill. The existing plant beds will be improved and planted in the spring of this year. This shelter will be enjoyed by the neighbors for many years to come.

POLICE **I**

Crime Maps and Statistics

Crime Investigations Division (CID)

CID assigned 76 new cases this month. CID closed 47 cases in February with the following dispositions: 19 cases were cleared by adult arrest, 0 cleared with juvenile arrest, and 28 were administratively closed, exceptionally cleared or were unfounded.

Cyber Crimes

The Cyber Crimes Unit, which investigates crimes involving but not limited to child pornography, network intrusion and online scams, continued to operate in cooperation with the US Secret Service (USSS) and the Federal Bureau of Investigations (FBI). The unit has eight open/active cases.

United States Marshal Task Force

The Bloomington office opened 13 felony cases and closed 11 of them. 10 hands-on felony arrests were made.

The Task Force arrested a subject wanted for residential burglary and recovered 2.8 grams of crack cocaine, located and arrested a subject wanted for criminal sexual assault and located and arrested a subject wanted for aggravated discharge of a firearm.

VICE Unit

The Vice Unit opened 10 cases, closed nine, and served two search warrants. They purchased 7.8 grams of crack cocaine, 4.6 grams of powder cocaine, 18 grams of cannabis, and .9 grams of heroin. They seized 2.9 grams of crack cocaine, 128 grams of methamphetamine and .1 gram of heroin.

Street Crimes Unit

Street Crimes made 18 probable cause arrests and 4 warrant arrests. They seized 21 grams of cannabis, 2 firearms and 4 vehicles.

Criminal Intelligence and Analysis Unit (CIAU)

During the month of February, staff in CIAU provided support in one homicide, a street level shooting and multiple theft cases. CIAU also produced a social media post related to eight theft cases with losses over \$10,000. The suspect was identified in under 30 minutes due to the post. Staff produced several analytical products for court on two 2016 violent felonies.

First Shift 7 a.m. – 3 p.m.

During the month, there was one selective speed detail and 15 school zone details. Many officers attended training in February including: Mental Health Awareness and De-Escalation, Evidence and Crime Scene Photography, PPCT, Vehicle Dynamics, CNU, Patrol Drug Investigations, SWAT, Child Death Investigation and Tactical Vision.

Second Shift 3 p.m. – 11 p.m.

During the month, numerous step details were conducted. Many officers attended training in February including: Mental Health Awareness and De-Escalation, Evidence and Crime Scene

Photography, Tactical Vision, SWAT, Breath Operator, Vehicle Dynamics, SFST, Patrol Drug Investigations and Criminal Law.

Third Shift 11 p.m. – 7 a.m.

In January, 3rd Shift Officers recorded 16 DUI arrests.

Notable calls for service include, during an attempt to repossess a vehicle on Mill St, the owners fled in the vehicle striking the tow truck and the two truck drivers. Officers stopped the vehicle and arrested the owner for DUI. Officers responded to a call of shots fired at a house in the 900 block of West Olive. Officers on a routine patrol of the Market Street parking garage discovered a deceased male in the stairwell, no foul play suspected.

Administration

- The Public Affairs Officer submitted several news releases, posted on social media, conducted some radio interviews, initiated and promoted new Downtown Neighborhood Watch promotion and initial meeting, was the keynote speaker for safety and bank robbery training at a local bank, served as the local media liaison at local Special Olympics event, promoted and attended Jefferson Street Community House events, instructed two classes for state conference for City of Bloomington inspectors in Springfield, attended a recruitment fair at Illinois State University, assisted on social media based cases, facilitated several community engagement events, was the keynote speaker for the Illinois State University Criminal Justice Associate and assisted with the promotion of police events.
- School Resource Officers responded to one bus accident, one runaway, conducted talks about finger prints, and the Chief judged a contest at Evans school for the School Resource Officers' office door decorations. Officers met with 11 students about to fight and calmed them down, removed 12 students from class for poor behavior and lack of cooperation with school administration, transported 13 students home after they were suspended for poor behavior and fighting, spoke to 11 parents regarding behavioral issues, theft and battery, spoke with 47 students throughout the month regarding behavior, challenges to fight and grades and had 16 calls for disorderly conduct.

Downtown

- There were 12 days of Downtown Hireback with a total of 44 pairs of officers, including 12 pairs assigned from 3rd shift patrol, worked during the month. Notable incidences include officers located two subjects had climbed over the fence at a bar to get into the beer garden on February 3rd. On February 9th, a male was escorted from a bar when he was refused service and provided water due to his intoxication level. He tried to regain entry and was forcibly removed from the bar. During this time he fell into against a police vehicle parked on the street causing damage to the front fender. February 22nd, five patrons were issued OVs for either minor in a tavern or fraudulent identification, bar staff was spoken to regarding keeping a closer eye on identification provided by patrons. February 25th, a male was involved in a fight which resulting in his transportation to the hospital for injuries. A suspect was later arrested for aggravated battery.
- Totals for the month include 265.25 overtime hours, 227 bar checks, 14 OVs, seven parking citations, 14 fights, 23 calls for service, two arrests, and seven towed vehicles. Ordinance violations were issued for one for challenge to fight, one for battery, two for fraudulent identification, nine for minor in a tavern, and one other.

COMMUNICATIONS CENTER

View Police Communications Report

- Telecommunicators answered 1,513 calls in less than 10 seconds and 45 calls in less than 20 seconds. This gives the communication center a 97% rating of calls answered within 10 seconds.
 The State of Illinois mandates that 90% of incoming 911 calls must be answered within 10 seconds.
- The Communications Center Manager (CCM) continued to work on the Telestaff project and the Emergency Operations Center. CCM attended the McLean County Disaster Council, Starcom Advisory Subcommittee meeting and the IL-TERT monthly meeting. Alert ordinance violations issued to date: 0.

View Expanded Water Department Reports

- Daily pumpage for February, 2018 was 8.8 million gallons per day, 0.6 mgd lower than the previous month. February, 2018 was 1 degree F warmer than average (30 F avg for February, 2018 versus 29 F long term average). Total rainfall for February, 2018 departed from the previous number of month's trend of precipitation deficits. February, 2018 precipitation total was 4.5", which is 2.57" higher than the long term average for the month.
- Nitrate levels in the both the Lake Bloomington Reservoir and the Evergreen Lake Reservoir are rising from the increased streamflow, but are currently both well below the 10 mg/l nitratenitrogen limit. Laboratory staff are closely monitoring the lakes and streams, and will continue the increased frequency of sampling over the next few months.
- Water levels in both Lake Bloomington Reservoir and the Evergreen Lake Reservoir rose after the heavy rainfall and snowmelt that occurred during the last half of February, 2018. Pumping operations were switched from Evergreen Lake to Lake Bloomington on February 12, 2018. Evergreen Lake was again utilized starting February 22nd, to avoid possible diminished water quality from Lake Bloomington after the heavy rains. Lake Bloomington received enough runoff to raise the level from 4.8 feet below spillway to have water flowing over the spillway. Evergreen Lake, with a much larger volume and a smaller drainage catchment than Lake Bloomington, rose approximately 2 feet. Normal precipitation between now and the end of spring should bring both reservoirs back to full capacity.
- Continued to replace and repaired water service lines and curb stops. Staff replaced and or repaired 27 service lines. Several of these were very old lead (the metal) service lines. Removal of lead from the system helps the City maintain safe water quality and is in accordance with lead water standards.

- The Department located/cleared 1,308 JULIES and issued 61 JULIES.
- Repaired 9 water main throughout the City.
- Serviced 3 fire hydrants throughout the City.
- Installed 53 Radio Frequency (RF) meters during February. The Department has converted approximately 98.2% of the total meter inventory.
- Staff installed 15 new residential water meters during the month of February and replaced 403 residential water meters.
- Staff installed 11 compound meters and replaced 5 meter measuring elements during the month of February.
- Drilling for the St. Peter Aquifer Test Well 1 began in August and was completed in November. Test Well 2 drilling began in December and reached total depth at the end of January. Test Well 2 surging and test pumping on is planned to occur in March.
- The Billing and Cashier representatives handled 4,004 incoming phone calls and placed 2,861 outbound phone calls in February 2018.
- The Water Director visited three classrooms at Chiddix Junior High School in late February to speak about engineering, water conservation, ecology efforts of the Water Department, and Department projects. In addition, each student received a leak detection kit along with a request to test their toilets for leaks.
