Dear City of Bloomington Resident,

In April 2013, voters in our community approved a municipal aggregation referendum allowing the City of Bloomington government to contract with an energy supplier to help residential and small commercial customers manage energy costs. After researching competitive pricing options, the City of Bloomington has chosen MidAmerican Energy Services. As a member of this aggregation, you will automatically receive a price of 5.07¢ per kWh for 100% renewable energy from June 2018 – June 2020.

Once you are enrolled, Ameren will send you a notification confirming MidAmerican as your new electric supplier. Your new rate will begin with your first available meter read date on or after May 30, 2018.

**Opt-Out Information**

You are not obligated to participate in the City of Bloomington’s electric municipal aggregation program. If you do not want to participate in this program, you have until April 11, 2018 to notify MidAmerican by one of the options below:

<p><small>If you elect not to participate in the municipal aggregation program, you may purchase electricity supply from a certified retail electric supplier or from Ameren (either fixed or hourly service).
