

# FIRE

# **View Expanded Monthly Fire Statistics**

The department ran 844 calls for service in the month of April, this was 31 less than March. The department responded to 173 (20.4%) fire incidents and EMS accounted for 671 (79.6%) incidents for April. The department averaged 28.1 incidents per day in April. Fire loss for April was estimated at \$326,550. Property loss was estimated at \$232,800



- with an estimated \$93,750 in contents lost. The fire loss was up compared to previous months as we had three structure fires that resulted in \$253,500 of damage.
- The department provided mutual aid 4 times this month and received mutual aid 5 times.
- Fire Investigators began or finished 4 fire investigations during the month.

- Our EMS personnel provided 64 hours of preceptor time to EMS students. BACC students had 55 hours of ride time with the department.
- On April 24 the department took delivery of a new fire engine, this piece of equipment will be placed in service sometime in May.
- On April 30 the department responded to a traffic accident on Market St. that involved a hazardous material. We were on scene several hours assisting with the mitigation of the situation. The product did not pose a threat to the public.

#### **HUMAN RESOURCES**

The Human Resources department partners with every department of the City on their human capital needs and interacts and serves all employees throughout their careers, as well as prospective employees. The staff includes twelve (12) full-time employees who focus on six primary areas: Employee Recruitment and Hiring; Employee and Labor Relations; Compensation and Benefits; Training and Development, Employee Wellness and Safety, and Community Relations.

#### Wellness

The annual employee wellness fair was held on April 20th at the Grossinger Motors Arena. The event drew in a record number of attendees, with approximately 200 employees. The purpose of the fair is to promote awareness of a variety of health topics; inform attendees of community services and resources; offer resources on health promotion and disease prevention; encourage camaraderie among coworkers; and motivate participants to make positive healthy behavior changes. Thirty-five health and benefits vendors participated in the fair. The event also included a healthy breakfast and free health screenings.

One hundred and seventy employees participated in biometric screenings held in April. Screenings were free for employees and included blood pressure, weight, and a full blood draw. The preventive service helps employees understand their health status and the steps they can take to improve their health. Screenings can help control healthcare expense growth by assessing the risk of employees, creating awareness, and identifying chronic conditions early enough to impact their trajectory.

# **HR College**

The HR Department created HR College for all persons who supervise individuals, with the intent to train supervisors on not just how to be more effective supervisors, but also about our own internal procedures related to all things HR. HR College provides guidance, education, information and assistance to our internal and external customers in a fiscally responsible manner consistent with our established departmental and City values and goals. The first training began on April 25<sup>th</sup>.

#### **Employee Recruitment and Hiring**

For the month of April, HR participated in the Heartland Community College "Mock Job Fair" for ESL/GED students. Students visited booths representing a variety of job fields. Students were provided feedback on how to network, interview preparedness, ask good questions and how leave a good lasting impression.

#### Golf Courses

- April unfortunately brought us the 2nd coldest April on record. With that, we were not able
  to get the three courses all open until April 12th. This is the latest opening day for all three
  courses in at least 20 years. Despite the unseasonably cold temperatures, the courses were
  still able to see over 3,500 rounds played in the month.
- The 4th Annual Green Jacket Open was held at The Den on Saturday, April 21st. The event was originally scheduled for April 7th but was postponed due to daytime highs in the 30's. A nearly full field of 25 teams came out to enjoy a fun day on the course.
- The Illinois Prep Tour brought over 150 players out to The Den at Fox Creek for one of their
  year opening events. They also brought an event of nearly 50 more beginning junior golfers
  to Prairie Vista. The Prep Tour brings many events to our courses throughout the year and
  does a great job in developing junior golfers.
- Superintendent of Golf, Jason Wingate, began his eighth year of a Friday morning golf segment on the Scott Laughlin show on WJBC. The segment runs each Friday from April

- through September at 8:10am. This segment covers a variety of golf topics and allows Jason to discuss what's going on with Bloomington Golf.
- Despite the cold April temperatures, the courses bounced quickly back into shape with the warmer weather at the end of the month.

# Miller Park Zoo

- Revenue from admissions was down 11.9 % for the current fiscal year. Last year, the revenue from admissions broke the all-time record for the Zoo in a fiscal year. This represents the sixth consecutive year the all-time attendance revenue record was broken. Attendance was down 12.1% for the current fiscal year compared to last year's attendance. This represents the second consecutive year the all-time attendance record was broken. Revenue from Education Program Fees and Rentals was down 2.8% for the current fiscal year.
- Revenue from Concessions, Carousel, and Animal Food Sales was down 4.4% for the current fiscal year compared to last year's numbers. The Zootique sales were down 2.8% for the current fiscal year, and overall Zoo revenue was down 10.1%.

# SOAR **I**

- SOAR will have 6 swimmers and 15 track athletes advancing to the Summer Games in June.
   Our soccer team took second place at their District event and will not be advancing as it was a Gold Medal only qualifier.
- There were 39 SOAR athletes that attended a Special Olympics Sports night hosted by the IWU Titans Athletic Department. The Titan athletes ran three stations: basketball, volleyball and running/jumping and then finished with 2 kickball games including SOAR and Titan athletes. Plans for a similar event in the fall are being discussed.
- Another SOAR athlete has been selected to attend the Special Olympics USA Games! Richard Garmon was invited to join the Illinois Delegation after a vacancy on the team occurred. Richard will be competing in bowling, joining another SOAR athlete, a SOAR Unified Partner and 3 SOAR coaches in Seattle in July.

#### Utility

- April is a very busy month for the utility division. Staff was busy opening up all park public
  bathrooms and drinking fountains. Park staff has to re-assemble all bathroom fixtures and
  install all the water meters. The utility staff also began the preparation for the opening of the
  spray parks in mid-May and the opening of the swimming pools at the end of May. The utility
  staff completed the annual boiler maintenance at both Holiday and O'Neil swimming pools.

# **POLICE**

# **Crime Maps and Statistics**

# **Crime Investigations Division (CID)**

CID assigned 89 new cases this month. CID closed 78 cases in November with the following dispositions: 21 cases were cleared by adult arrest, 5 cleared with juvenile arrest, and 52 were administratively closed, exceptionally cleared or were unfounded.

#### **Cyber Crimes**

The Cyber Crimes Unit, which investigates crimes involving but not limited to child pornography, network intrusion and online scams, continued to operate in cooperation with the US Secret Service (USSS) and the Federal Bureau of Investigations (FBI). The unit has six open/active cases.

#### **United States Marshal Task Force**

The Bloomington office opened seven felony cases and closed four of them. Three hands-on felony arrests were made.

The task force conducted a round of indictment warrants leading to the arrest of 25 people and the seizure of guns and illegal narcotics. The task force assisted in the investigation and arrest of two subjects involved in homicides and recovered two handguns used in the crimes.

#### **VICE Unit**

The Vice Unit opened seven cases, closed six, and served two search warrants. They purchased 7.9 grams of crack cocaine, 0.1 grams of powder cocaine and 109 grams of spice. They seized 18.6 grams of crack cocaine, 370 grams of cannabis, 0.1 grams of heroin and 6 dosages of hydrocodone.

#### **Street Crimes Unit**

Street Crimes made 12 probable cause arrests and four warrant arrests. They seized 400 grams of cannabis, 1 gram of heroin, 6 grams of spice, 0.1 gram of methamphetamine, 10 dosages of hydrocodone, \$1762 in currency and towed nine vehicles.

### **Criminal Intelligence and Analysis Unit (CIAU)**

During the month, staff provided tactical support on cases including multiple fatal heroin overdoses, thefts involving large monetary losses; provided telecommunication analysis on four cases; prepared demonstrative evidence and presented in court for a local gun case involving a gang member; and prepared material for the Public Safety and Community Relations Board.

# First Shift 7 a.m. – 3 p.m.

During the month, there were 19 school zone details and nine interdiction details. Officers attended the YMCA Strong Kid Campaign kickoff. Patrol officer attended a considerable amount of training including Pressure Point Control Tactics, Surviving Hidden Weapons, Building Search, Rifle, Law Update, Criminal Interview and Interrogation, SWAT, ILEAS, Drug Identification, Street Sergeant and Crisis Negotiation.

# Second Shift 3 p.m. – 11 p.m.

Patrol conduced two substantial investigations into methamphetamines during the month, large amounts of methamphetamines were seized. Several officers attended training including Street Survival, SWAT, Rifle, Body Worn Camera, Lead Homicide Investigator, Building Search Tactics, and Field Sobriety Testing.

#### Third Shift 11 p.m. - 7 a.m.

Third shift officers recorded 13 DUI arrests. Notable calls for service include on April 5<sup>th</sup> a burglary in progress was interrupted by officers dispatched to 1100 block of Locust. The suspects fled in a vehicle toward 1-74. The pursuit was terminated for safety reasons. The case is currently being investigated. Large fights were reported on April 7<sup>th</sup> and April 15<sup>th</sup>. A vehicle burglary interrupted on April 19<sup>th</sup> near Clearwater and Royal Pointe. The stolen items were recovered. On April 21<sup>st</sup>, officers assisted the Bloomington Fire Department at an apartment fire by evacuating the building's occupants. On April 28<sup>th</sup>, two subjects with knives began fighting downtown. Both subjects were subdued by officers and arrested.

#### Administration

- The Public Information Officer submitted several news releases, posted on social media, conducted television and radio interviews, conducted corporate safety training for Easter Seals Central Illinois, conducted public safety training at an Illinois Heart and Lung Associate event, facilitated active shooter/bank robbery training for Illinois State University Credit Union, presented safety training to the 3<sup>rd</sup> grade classes at Corpus Christi, facilitated Illinois State University victim's presentation, assisted with the national Drug Enforcement Administration prescription drug take back program, promoted the Distracted Driving for IDOT (grant/enforcement), assisted with a large donation from Clemons and Associates Insurance Company for the children's room in the department, was the key note speaker for a Girl Scout event, served as the local media liaison for teen prom safety, continued working with the Human Resources department promoting recruitment and assisted BPD investigations on social media cases.
- School Resource Officers attended 5<sup>th</sup> grade orientation night, spoke with several kindergarten classes, met with students about improper use of social media, and mediated a meeting of several students and their guardians. Officers met with 14 students about to fight and calmed them down, removed 13 students from class for poor behavior and lack of cooperation with school administration, transported several students home after they were suspended for poor behavior and fighting, spoke with parents regarding behavioral issues in schools, thefts and batteries. Officers responded to 12 fights, four calls for disorderly conduct, two calls for battery, and multiple thefts.

#### **Downtown**

- There were 12 days of Downtown Hireback, with a total of 41 pairs of officers including nine pairs assigned from 3<sup>rd</sup> shift patrol working during the month. Notable incidences include officers issued an ordinance violation for battery and possession of cannabis to a subject after a small altercation. On April 27<sup>th</sup>, officers stopped a vehicle driving the wrong way on a street downtown. The driver was found to be intoxicated.
- Totals for the month include 267 hours of overtime, 193 bar checks, one DUI, 14 ordinance violations, 13 parking citations, 11 fights, 19 calls for service, two arrests and 12 vehicles towed. Ordinance violations were issued as follows: three for challenge to fight, one for battery, one for public urination, two for illegal consumption, one for open alcohol, four for fraudulent identification, seven for minor in a tavern and one other.

#### **COMMUNICATIONS CENTER**

#### **View Police Communications Report**

- Telecommunicators answered 1,594 calls in less than 10 seconds and 22 calls in less than 20 seconds. This gives the communication center a 99% rating of calls answered within 10 seconds. The State of Illinois mandates that 90% of incoming 911 calls must be answered within 10 seconds.

# **View Expanded Water Department Reports**

- Daily pumpage for April, 2018 was 8.5 million gallons per day, the same as the previous month. April, 2018 was significantly cooler than average (44 F avg for April, 2018 versus 53 F long term average). Total rainfall for April, 2018 was only 1.46", which is 2.26" lower than the long term average for the month.
- Nitrate concentrations for both reservoirs are below the 10 mg/l as N regulatory limit, with Evergreen Lake remaining low concentrations. Laboratory staff are closely monitoring the lakes and streams, and will continue the increased frequency of sampling over the next few months.

- We continued pumping from Evergreen Lake during April, 2018. Evergreen Lake was below spillway elevation at the start of April, but recovered to full capacity during the month.
- Lake Bloomington remained above spillway elevation throughout the month. Both reservoirs are back to full capacity, following the extended period of low levels during fall and winter.
- Continued to replace and repaired water service lines and curb stops. Staff replaced and or repaired 22 service lines. Several of these were very old lead (the metal) service lines.
   Removal of lead from the system helps the City maintain safe water quality and is in accordance with lead water standards.
- The Department located/cleared 2,017 JULIES and issued 35 JULIES.
- Repaired 3 water main throughout the City.
- Serviced 3 fire hydrants throughout the City.
- Installed 53 Radio Frequency (RF) meters during April. The Department has converted approximately 98.4% of the total meter inventory.
- Staff installed 2 new residential water meters during the month of April and replaced 192 residential water meters.
- Staff installed 5 compound meters and replaced 22 meter measuring elements during the month of April.
- Drilling for the St. Peter Aquifer Test Well 1 began in August, 2017 and was completed in November. Test Well 2 drilling began in December 2017 and reached total depth at the end of January. Test Well 2 surging and test pumping was completed in March. Video and plumbness testing occurred on both wells in April, 2018.
- The Billing and Cashier representatives handled 4,408 incoming phone calls and placed 2,190 outbound phone calls in April 2018.
