SNOW ROUTE PROCEDURE

PURPOSE

The purpose of this procedure is to ensure coordination of efforts between our Department and Public Works in the event of a parking ban, due to adverse weather conditions, as provided in Chapter 29, Section 119.3 of the City Ordinance.

In addition to the aforementioned City Ordinance, Police Department members should also familiarize themselves with the "Towing Procedure Policy" for the Public Works Department.

PROCEDURE

The Director of Public Works, or his designated representative, will have the initial responsibility of declaring a parking ban.

It may be necessary for a patrol supervisor to notify the Director of Public Works during non-working hours of the need to implement the Snow Route Procedure. His decision will be based on criteria set forth in Section 119.3 of this ordinance.

If notification cannot be made by the patrol supervisor to the Director of Public Works, or his designated representative, implementation of this ordinance may then be started by the patrol supervisor. This will be done only after all attempts by Police to contact representatives of Public Works have failed.

INITIAL NOTIFICATION

Upon notification that a parking ban has been declared by the Director of Public Works, or his designated representative, a patrol shift supervisor will notify the Department's towing contractor and inform him the parking ban is in effect. This notification is necessary to ensure a prompt response if their service is needed.

All on-duty personnel will be notified of the parking ban implementation.

Such notification will be logged on the department's daily activity sheet at the time of notification.

TOWING VEHICLES ON PRIMARY SNOW ROUTES

All streets designated PRIMARY routes by City Ordinance shall be, for the purpose of this procedure, divided into two categories: PRIMARY and SECONDARY SNOW ROUTES. The

only distinction between these two categories is that PRIMARY routes should be cleared of parked vehicles first, if possible.

Vehicles found parked on PRIMARY routes will be issued a parking citation and then towed by the city towing contractor. A tow sheet will be made for each vehicle, and the parking citation will be affixed to the original copy. A mandatory \$10 release fee will be noted on the tow sheet. Towing will be at the direction of the Public Works Department.

SECONDARY SNOW ROUTES

At the time a parking ban is announced, all officers will be responsible for issuing parking citations on these routes. Depending on available time, these routes should be checked periodically during an officer's shift, to ensure violators are issued a parking citation.

Vehicles parked on SECONDARY ROUTES are NOT subject to tow as are those parked on PRIMARY ROUTES.

ISSUANCE OF PARKING CITATIONS (CHAPTER 29, SECTION 119.9)

Proper wording for this violation will be "PARKING ON SNOW ROUTE" for which the fine is \$50.00. It is essential that the correct time and date be recorded on the parking citation since this violation occurs only during the declaration of a parking ban.

TERMINATION OF PARKING BAN

Termination of the parking ban will be done by the Director of Public Works or his designated representative. Once notice of termination has been received by the patrol supervisor, all on-duty personnel and the towing contractor should be informed. This information also needs to be recorded on the Department's daily activity sheet, to ensure notification within the Department.

Due to diverse circumstances which may exist at any given time, criteria for the removal of vehicles in violation of this ordinance have not been set. The patrol supervisor will assess the situation and determine the best method for the removal of the illegally parked vehicles.

During such time that a parking ban is in effect, the Public Works Department will maintain a Snow Command Center. Updated information on street conditions will be maintained through the Snow Command Center.
