COMMUNITY DEVELOPMENT

Building Safety

• There were a total of 708 Construction Permits issued in July of 2018, which is up from the 653 Construction Permits issued in July of 2017. The value of the construction decreased from \$10,569,013 in the prior year 2017 to \$7,804,000 in July of 2018. (It should be noted

that an additional \$2.9MM is shown below for a commercial generator replacement as electrical permit and not included as construction).

- Four new projects were valued in excess of \$1,000,000 for Outback Steakhouse at 1637 E. Empire (\$1,700,000); Interior remodel for the H & M Clothing Store at 1603 E. Empire (\$1,040,000); Generator replacement at 2325 W. Market for telecomm facility (\$2,978,782); and construction of the McLean County Eye Center at 1107 Airport Road (\$3,721,588).
- Coordination on contracted services for a commercial plans examiner/inspector. Approved under Other Professional Services line item in FY 2019 Departmental Budget.

Planning, Zoning and Historic Preservation

- Staff continued work on the Zoning Ordinance update and preliminary coordination on Sign Ordinance update.
- The ZBA denied a setback variance for a carport at 702 East Miller and approved a setback variance for a garage addition at 40 Sunset Road.
- The HPC approved Certificates of Appropriateness for 931 W. MacArthur (windows/siding) and 709 E. Taylor (lattice). Three Funk Grants were approved for properties located at 1005 E. Jefferson, 931 W. MacArthur, 709 E. Taylor. And one Rust Grant was approved for 215 East Front Street.

Downtown Development

- Coordination for Special Events including First Friday "Artistic Freedom", Bloomington Edge Block Party, Bloomington Criterium Bike Race, Lincolns Festival on Route 66, Bistro 25th Anniversary Block Party and Farmers Market.

View Expanded Monthly Fire Statistics

- July saw a decrease in the number of incidents that the department responded to, we had 54 fewer calls. The department responded to 864 incidents compared to 918 in June.
- Of the 864 incidents 703 (81.27%) of those were EMS incidents and 161 (18.63%) were fire incidents. This averages out to 27.87 incidents per day.
- For the second month in a row I am pleased to report that we did not have any significant structure fires that resulted in any major fire loss. Fire loss for the month was \$3530.

- Truck 1 was the busiest fire apparatus with 153 runs.
- Medic 1 was the busiest ambulance with 198 runs.
- Tuesday was our busiest day of the week with 159 incidents over the month, and 11:00 am to 12:00 pm was our busiest time of the day.
- The department provided mutual aid 15 times this month and received mutual aid 5 times.
- Our EMS personnel provided 299 hours of preceptor time to EMS students and 16 hrs. to nurses.
- On July 22 we placed the new Engine 1 in service at Station 1 by conducting a push-in ceremony. This is a tradition in the fire service that we have not done in the past and plan on doing with any new vehicles in the future.

Golf Courses

Miller Park Zoo 📑

- Revenue from admissions was down 6.7% for the current fiscal year. Attendance was down 6.4% for the current fiscal year compared to last year's attendance. Revenue from Rentals was up 8.9% for the current fiscal year.
- Revenue from Concessions, Carousel, and Animal Food Sales was up 8.9% for the current fiscal year compared to last year's numbers. Education revenue was up 1.8%, and Zootique sales were down 9.3% for the current fiscal year, and overall Zoo revenue was down 3.2%.

POLICE 📑

Crime Maps and Statistics

Crime Investigations Division (CID)

CID assigned 69 new cases this month. CID closed 30 cases in June with the following dispositions: 16 cases were cleared by adult arrest, one cleared with juvenile arrest, and 60 were administratively closed, exceptionally cleared or were unfounded.

Cyber Crimes

The Cyber Crimes Unit, which investigates crimes involving but not limited to child pornography, network intrusion and online scams, continued to operate in cooperation with the US Secret Service (USSS) and the Federal Bureau of Investigations (FBI). The unit has five open/active cases.

United States Marshal Task Force

The Bloomington office opened 11 felony cases and closed eight of them. Six hands on felony arrests were made. The Task Force located and arrested a subject wanted for homicide.

VICE Unit

The Vice Unit opened 10 cases, closed eight, and served three search warrants. They purchased 6.1 grams of crack cocaine, 10.3 grams of powder cocaine, 15.3 grams of cannabis, and 4 grams of ecstasy. They seized 25.1 grams of powder cocaine, 36 dosage units of Xanax, one firearm, and one vehicle.





Street Crimes Unit

Street Crimes made 10 probable cause arrests and 13 warrant arrests. Assisted VICE with investigations. They towed four vehicles.

Criminal Intelligence and Analysis Unit (CIAU)

During the month of July, staff continued supporting two homicide investigation cases from June in addition to working on a third homicide case that took place this month. A considerable amount of time was spent working on crime data requests from the press. Staff provided ongoing support to several juvenile weapons cases in the adjudication phase.

First Shift 7 a.m. – 3 p.m.

During the month, officers attended the following trainings: Pistol training, SWAT, Sig Armorer, Reconstruction Scanner, and Desert Snow interdiction training. Officers participated in or attended the following community events: Park to Park Run, the Bloomington Edge Music Festival, Criterium Race, Lincoln Festival, Heritage Foundation Ride, and the Prairie Aviation First Responder's Day.

Second Shift 3 p.m. – 11 p.m.

During the month of July, officers conducted several sex offender compliance checks. Managed a high call load.

Third Shift 11 p.m. – 7 a.m.

- Third shift officers recorded eight DUI arrests.
- Notable calls for service include a call on July 3rd, officers responded to a report of a shooting and found a victim that had been shot through both legs. There was no cooperation from the victim. Officers conducted traffic control at Miller Park during the July 4th celebration. On July 9th, officers conducted a routine pedestrian stop on two subjects. During the stop, one of the subjects began fighting. It was discovered the subject was armed with a handgun. Three officers were injured during the arrest. On July 16th, officers arrived on scene of a subject in cardiac arrest. Officers used an AED effectively to revive the subject until rescue arrived. July 17th, a subject was stabbed during an altercation and dropped off at the emergency room anonymously. The victim later succumbed to his injuries. A suspect was located shortly after the incident and arrested. On July 26th, a window was broken at a local business. The subject burglarizing the business was cut in the process. The suspect was arrested after seeking treatment at a local hospital. July 28th, several arrests were made following a fight involving multiple subjects. On July 29th, officers responded to a call of shots fired. It was determined a vehicle was damaged.

Administration

The Public Affairs Officer submitted several news releases, posted on social media, conducted several television and radio interviews, worked with the City of Bloomington Human Resources to promote police recruitment, conducted safety training for various entities, facilitated and promoted Ice Cream with a Cop, Illinois Special Olympics Lip Sync, and Project with a Cop, attended the Multicultural Awards at Illinois Wesleyan University, led a safety talk at Montessori school, participated in several weekend community engagement events, and assisted with promotion for upcoming and current law enforcement events.

Downtown

- There were 12 days of Downtown Hireback, with a total of 25 pairs of officers, including five pairs assigned from 3rd shift patrol working during the month. Notable calls for service include on July 6th, officers made contact with a subject who appeared to be intoxicated. It was found the subject was under 21 and had used a fraudulent ID to get into a bar. On July 14th, a subject was attempting to enter a bar using a fraudulent ID. When officers made contact they realized the subject had already consumed alcohol and the subject admitted to drinking at another bar prior. Also on the 14th, officers arrested a subject downtown on a McLean County warrant. On July 20th, officers arrested a subject downtown on a McLean County warrant. On July 21st, ordinance violations were issued to five separate subjects for minor in tavern after they were found to have gained entry into the bar with fraudulent IDs. On July 27th, officers spotted a subject who had fled from officers earlier in the evening related to a retail theft call for service. The subject ran from officers again when they tried to establish contact downtown. The subject was caught on the lawn of the Bloomington Center for Performing Arts and arrested.
- Totals for this month include 174 hours of overtime, 100 bar checks, 11 ordinance violations, two parking citations, two fights, six calls for service, three arrests, and two vehicles towed. Ordinance violations were issued as follows: two for public urination, two for illegal consumption, one for open alcohol, one for use of fraudulent identification, and five for minor in tavern.

COMMUNICATIONS CENTER

View Police Communications Report

- Telecommunicators answered 2,074 calls in less than 10 seconds and 40 calls in less than 20 seconds. This gives the communication center a **98% rating** of calls answered within 10 seconds. The State of Illinois mandates that 90% of incoming 911 calls must be answered within 10 seconds.
- Communications conducted final end-user training for CAD Go-Live. System Assurance testing completed. CAD Go-Live successful on July 31, 2018.
- Alarm ordinance violations issued to date: 104

- Approximately 24,500 residences are serviced weekly and an average of 29.80 pounds of household garbage were picked up each week at these locations during July 2018.
- 544 miles were swept during the month of July 2018.
- The front office staff received 1,539 telephone calls during July 2018.
- Fleet received 1,012 phone calls.

WATER

- The Water Department released the 2017 Annual Consumer Report on the Quality of Tap Water. The report has been included in recent utility bills and is available online at the City's website. In addition, hard copies are available at City Hall, Division Street facilities, and other locations in the community.
- Daily pumpage for July, 2018 was 11.9 million gallons per day, 0.7 mgd higher than the previous month and in the upper range of the July averages for the previous 3 years. July, 2018 was 2 degrees cooler than average (74 F avg for July, 2018 versus 76 F long term average). Total rainfall for July, 2018 was 2.31" as reported for Hudson by Accuwearher.com, which is 1.68" lower than the long term average for the month.
- Nitrate concentrations for both reservoirs are well below the 10 mg/l as N regulatory limit, with Evergreen Lake remaining low concentrations. Laboratory staff are closely monitoring the lakes and streams, and will continue to monitor conditions.
- We continued pumping from Evergreen Lake during July, 2018. Evergreen Lake levels decreased to around 1.5 feet below spillway elevation, which is fairly normal for the end of July.
- Lake Bloomington ended the month slightly below spillway elevation.
- Continued to replace and repair water service lines and curb stops. Staff replaced and / or repaired 15 service lines. Several of these were very old lead (the metal) service lines. Removal of lead from the system helps the City maintain safe water quality and is in accordance with lead water standards.
- The Department located / cleared 2,287 JULIES and issued 41 JULIES.
- Repaired 1 water main break throughout the City.
- Replaced 2 fire hydrants throughout the City.
- Szarek Drive water main replacement project was completed on July 13, 2018, with all punch list items completed.
- The council awarded the Lake Bloomington water main replacement project to George Gildner, Inc. The City held a public meeting on June 25, 2018, at Davis Lodge. Construction started June 26, 2018. As of August 1, 2018 the contractor has roughly 45% of the project completed.
- Installed 16 Radio Frequency (RF) meters during July. The Department has converted approximately 98.5% of the total meter inventory.
- Staff installed 15 new residential water meters during the month of July and replaced 208 residential water meters.
- Staff installed 6 compound meters and replaced 9 meter measuring elements during the month of July.
- Drilling for the St. Peter Aquifer Test Well 1 began in August, 2017 and was completed in November. Test Well 2 drilling began in December 2017 and reached total depth at the end of January. Test Well 2 surging and test pumping was completed in March. Video and

plumbness testing occurred on both wells in April, 2018. Well 1 blockage issue was partially addressed in June and July.

- The Billing and Cashier representatives handled 4,551 incoming phone calls and placed 2,124 outbound phone calls in July 2018.
- Lake Parks Staff, with the addition of a new slope mower, prepared Evergreen Lake and Lake Bloomington dams for the Spillway Improvement Project that was recently awarded to Stark Excavating.
- The Davis Lodge was rented twelve times in July of 2018, versus 13 rentals in July of 2017.
- City of Bloomington City Council approved one Lake Lease Transfer Petition.
- Civilian Patrol completed the purchase of a new patrol boat. The patrol boat was delivered on July 26, 2018.
- The council awarded the Lake Bloomington Water Treatment Plant roof replacement project to CAD Construction, Inc.

INFORMATION SERVICES

- Began replacement of City-wide network core equipment. New core will run parallel to old core for the mid-term future.
- Replaced aging Wi-Fi access points in Police and Fleet garages.
- Upgraded wide area network (WAN) connections at Miller Park Zoo, Highland Pro Shop, Prairie Vista Pro Shop and The Den Pro Shop. New connections are about the same price but approximately 20 times faster.
- After months of testing, began implementation of new networking technology (CradlePoint routers) in Fire and Police emergency response vehicles.
- Completed implementation and go-live of new Fire/EMS Reporting solution (Imagetrend).
- Completed implementation and go-live of new Parks and Recreation registration solution (MaxGalaxy).
- Continued working with BPD in support of body-worn camera solution pilot testing. Configured iPods for network connectivity and configured cameras for video upload to cloud.
- Working with BPD, completed implementation and go-live of new version of the Computer Aided Dispatch (CAD) system.
- Completed upgrade of CAD system decision support solution (Paramount)
- Completed testing, implementation and migration of all City computers to new version of McAfee endpoint security solution.
- Continued upgrade/replacement of city-wide desktop, laptop and tablet computers
- Completed Operating System (OS) image for Fire Department replacement mobile data terminals (MDT).
- Revamped the Information Services process of managing computing technology inventory, including a new recycle/disposal process.
