View Expanded Monthly Fire Statistics

- December was closer to normal with the number of incidents we responded to. The department responded to 906 incidents compared to 830 in November.
- The department responded to 734 EMS incidents which was 81% of the calls for the month and 172 fire incident which was 19% of the incidents.
- Fire loss for the month was estimated at \$56,600. We had one significant fire at the end of the month, this was at 405 W. Graham with an estimated fire loss of \$40,000. We had 2 vehicle fires that resulted in \$16,600 in fire loss.
- Our other significant incident that we responded to was the school bus accident out on Interstate 74 early in the month. Our units responded mutual aid at the request of Bloomington Township Fire Protection District. We responded with Truck 2, Engine 4, Medic 2, Medic 4, EMS 1, Battalion 1, and Chief 2. Our crews assisted with medical treatment and extrication of two individual on the bus and the driver of the semi. Our crews did an excellent job with these tasks.
- The department averaged 29.2 incidents per day.
- Department fire investigators investigated 3 fires in October.
- Truck 1 was the busiest fire apparatus with 155 runs.
- Medic 1 was the busiest ambulance with 302 runs.
- Saturday was our busiest day of the week with 144 incidents over the month
- 12:00 pm to 1:00 pm was our busiest time of the day.
- The department provided mutual aid 7 times this month and received mutual aid 1 times.
- Our EMS personnel provided 71 hours of preceptor time to EMS students and 26 hours to BACC students.

POLICE **I**

Crime Maps and Statistics

Crime Investigations Division (CID)

CID assigned 44 new cases this month. CID closed 31 cases in December with the following dispositions: 10 cases were cleared by adult arrest, five cases by juvenile arrest and 16 were administratively closed, exceptionally cleared or were unfounded. The detectives dedicated most of their hours investigating a homicide which occurred in early December.

Cyber Crimes

The Cyber Crimes Unit (CCU), which investigates crimes involving but not limited to child pornography, network intrusion and online scams, continued to operate in cooperation with the US Secret Service (USSS) and the Federal Bureau of Investigations (FBI). In December, CCU examined 51 items of digital media. Of those, 29 were mobile devices and 22 were computer hard drives or other storage media. CCU conducted digital forensic exams in support of criminal investigations, provided support in recovering surveillance video systems for investigations, and provided Historical Cell Site analysis for these investigations.

United States Marshal Task Force

The Bloomington office opened nine felony cases and closed seven. Six hands on felony arrests were made. The Task Force is assisting on investigations of recent homicides.

VICE Unit

The Vice Unit opened eight cases, closed six cases and served two search warrants. They purchased 10.6 grams of powder cocaine and 30 dosage units of methamphetamine. They seized .9 grams of crack cocaine, 67 grams of powder cocaine, two firearms, and \$4,678 United States currency.

Street Crimes Unit

Street Crimes made nine probable cause arrests and eight warrant arrests. They seized 13 grams of cannabis, 25 grams of crack cocaine, .25 grams of methamphetamine, and towed seven vehicles.

Criminal Intelligence and Analysis Unit (CIAU)

During the month of December, CIAU staff spent considerable time providing investigative support on the homicide which occurred in early December. Staff began to gather data and process information for the production of year end reports. Staff produced crime series bulletins for internal and external consumers.

First Shift 7 a.m. -3 p.m.

Officers participated in the following trainings and community activities: Building Searches, SWAT, Crisis Negotiation, Christmas parade escort, a funeral escort for Mt. Pisgah, and Toys for Tots. Officers performed five school zone checks and five special radar details.

Second Shift 3 p.m. – 11 p.m.

Officers attended the following trainings: Legal Update, De-Escalation, Search and Seizure, and First Aid. Notable calls for service include officers responded to a call of shots fired. No injuries were reported but a window was shot out.

Third Shift 11 p.m. – 7 a.m.

- Third shift officers recorded 17 DUI arrests.
- Notable calls for service include on December 5th, officers responded to reports of a shooting. Upon arrival officers located a victim deceased in the residence. The incident is currently under investigation. December 10th, officers conducting a business check found the front door of a local business shattered and several cell phones taken. Store management assisted police in tracking one of the stolen phones to a location where a stolen vehicle was located. Bloomington officers retrieved the car for evidence, recovered the phones and took two subjects into custody for several burglaries in the area. On December 25th, officers responded to a call of shots fired through the ceiling of an apartment. No one was in the apartment when officers arrived but a search warrant was obtained. No injuries were reported. This incident is currently under investigation. December 31st, New Year's Eve, was extremely busy with intoxicated subjects and fights at numerous locations.

Administration

School Resource Officers (SRO) met with many students regarding proper use of social media, grades, success in school, cyber bullying and bullying, challenges to fight, and poor behavior. SROs attended Ben Elementary School as a guest reader to bilingual students. The Public Information Officer (PIO) organized a Chief's Focus Meeting and the Shop with a Cop event. The PIO spoke with Normal West High School students, attended a McLean County Community Action event, conducted several interviews with local media, and created safety videos for neighborhood watch members and social media posts.

Downtown

• There were 13 days of Downtown Hireback, with a total of 38 pairs of officers, including eight pairs assigned from 3rd shift patrol working during the month. Notable calls for service include on December 14, officers took a report of two subjects fighting at an establishment. During the investigation, it was found the subjects were not fighting each other. Staff stated one subject had

shattered the window of a door while being escorted out, but the subject stated he was pushed into the door by the staff. Due to lack of evidence the subject was not arrested. Also on the 14th, officers observed a subject on the ground unconscious and bleeding from head. It was found the subject had been kicked out of an establishment for fighting with other patrons. The subject also tried to fight with another individual outside and was pushed away, which is when the subject fell. The subject was transported to the hospital and contacted later. The subject had no memory of the events due to the level of intoxication. On December 15th, officers arrested a subject following a fight at an establishment. The fight originated when two other subjects who were fighting were separated by the arrested subject. Additional subjects jumped in and began hitting the individual who tried to separate the subjects. The additional subjects fled the scene but were quickly detained by officers. December 22nd, officers took a report a criminal damage to property at an establishment. Two suspects were identified by the staff but no evidences was found to warrant an arrest. On December 28th, officers working a traffic detail stopped a vehicle for improper lane usage. During the traffic stop and interview of the driver an arrest was made for no valid driver's license. Following the arrest and subsequent search, charges of possession of methamphetamine with intent to deliver, possession of controlled substance, possession of drug equipment and other traffic related charges were added.

• Totals for this month include 257 hours of overtime, 157 bar checks, six ordinance violations, 14 parking citations, three traffic citations, nine fights, 16 calls for service, four arrests, and 13 vehicles were towed. Ordinance violations were issued as follows: one for public urination, two for illegal consumption, and three for minor in a tavern.

COMMUNICATIONS CENTER

View Police Communications Report

- Telecommunicators answered 1,803 calls in less than 10 seconds and 30 calls in less than 20 seconds. This gives the communication center a 98% rating of calls answered within 10 seconds. The State of Illinois mandates that 90% of incoming 911 calls must be answered within 10 seconds.
- Communications Center Manager worked on policy updates for Police Priority Dispatch System Implementation and attended Dispatch Review Committee meetings. Three probationary Telecommunicators are currently in the training program. Alarm ordinance violations issued to date: 226.

McLean County Solid Waste Program Q3 Report

- The Front office administrative staff received 1,525 telephone calls, fleet received 631 phone calls, while the billing staff handled 2,201 incoming phone calls and placed 1,173 outbound phone calls.
- The Department released the 2017 Annual Consumer Report on the Quality of Tap Water. The report has been included in recent utility bills and is available online at the City's website. In addition, hard copies are available at City Hall, Division Street facilities, and other locations in the community.
- Luke Thoele, P.E. was named as the Assistant City Engineer.
- Temporary pavement markings were installed on Fairway/Regency Drive from Empire Street to Oakland Avenue. Instead of the old four lane road, the new lane layout is based on a three lane section which includes one through lane each direction. As well as, a center two-way left-turn lane.

Final pavement markings which will also include bicycle lanes will be completed in the spring of 2019. A section of Fairway Avenue from Robinhood Lane to Empire Street will be resurfaced in the spring of 2019.

- The contractor for the St. Peter Aquifer wells was diverted to complete emergency repairs at another public water supply during the month of December. The acidification and pump testing work is anticipated to begin in January 2019.
- A revised draft of the master plan was submitted by the consultant for the Water Division SCADA Master Plan and is currently being reviewed for accuracy and completeness.
- Organizing the Water Division project records and scanning of as-built plans continued through December 2018.
- Approximately 24,500 residences are provided weekly garbage collection. An average of 25.14 pounds of household garbage were picked up each week at each location during the month of December.
- Fleet continues to maintain the leaf collection equipment during the prolonged leaf collection season.
- Daily water pumpage for December, 2018 was 8.3 million gallons per day, 0.2 mgd lower than the previous month and was 0.3 mgd lower than the average of the previous 3 years. December, 2018 was 3 degrees warmer than average (33 F avg for December, 2018 versus 30 F long term average). Total precipitation for December, 2018 was 3.74" as reported for Hudson by Accuweather.com, which is 0.52" higher than the long term average for the month. 0.3 inches of snow fell in December, 2018.
- Nitrate concentrations for both reservoirs are well below the 10 mg/l as N regulatory limit.
 Laboratory staff are closely monitoring the lakes and streams, and will continue to monitor conditions.
- Increased reservoir levels experienced in December, 2018 allowed us to switch from Lake Bloomington, which was utilized in October and November as our water source, to Evergreen Lake. We switched pumping from Lake Bloomington to Evergreen Lake to alleviate taste and odor issues experienced during the month. Evergreen Lake levels were approximately 4 feet below spillway elevation at the end of October, prompting concerns of potentially elevated nitrate concentrations from spring runoff. Precipitation in December resulted in a rise in Evergreen Lake elevation from 717.0 feet (3 feet below full reservoir) at the start of the month to 1.25 feet below top of spillway at the end of the month. Lake Bloomington had flow over the spillway during the entire month of December, 2018.
- Continued to replace and repair water service lines and curb stops. Staff replaced and / or repaired 28 service lines. Several of these were very old lead service lines. Removal of lead from the system helps the City maintain safe water quality and is in accordance with lead water standards.
- The Department located / cleared 1,229 JULIES and issued 43 JULIES.
- Repaired 13 water main breaks and replaced 1 fire hydrants throughout the City.
- Installed 13 Radio Frequency (RF) meters during December. The Department has converted approximately 98.7% of the total meter inventory.
- Meter service staff installed 12 new residential water meters during the month of December and replaced 322 residential water meters.
- Staff installed 3 compound meters and replaced 6 meter measuring elements during the month of December.
- Staff completed a total of 1,712 service requests during the month of December.
- Lake Evergreen Electrical conversion is almost complete. Motor #1 rewind and repairs are scheduled to be completed on the 10th of January. Motor #1 and the RTU are tentatively scheduled to be installed on the 11th or 14th of January.
- South Main pressure reducing valve is being install on the 8th of January. This will help us to separate our water system pressure zones south of Veterans Parkway.

- Main Water Treatment Plant roof replacement is 95% complete.
- Staff continues to collect and process the new Lake Bloomington Boat Dock permit applications. To date, staff has processed 61 applications.
- Staff has removed and refurnished all park signs around Lake Bloomington and repainted and repaired the inside of the Maintenance Shop at Lake Bloomington.
- The Davis Lodge was rented 2 times in December, 2018, compared to 4 times in December, 2017.
