I am reaching out to echo the work of local organizers in Bloomington/Normal on the COVID-19 crisis. I am urging you all to take immediate, concrete action to alleviate the affects of the crisis on your residents, particularly our community's most vulnerable members.

I know you are proud of the food distributors, grocery store runners, and mask-sewers in Bloomington/Normal-- I am, too. I've even signed up to volunteer for the McLean County COVID-19 Mutual Aid Team to do my part! However, now is not the time for elected officials to sit back and wait for churches, charities, and kind hearts to do the work you should be doing yourselves.

I am especially concerned about securing safe living spaces for our housing insecure residents who don't have a place to self-isolate during the stay at home order, about victims of domestic violence who should not be quarantined with their abusers, about residents in high density housing who are at an increased risk of infection, and about people being detained in the county jail pre-trial (not because they have been convicted but because they cannot afford to post bond) who are at enormous risk of widespread infection (and who should instead be at home self-isolating with their families). As our elected officials, you have an opportunity to step up to this moment and designate alternative housing: all publicly owned vacant homes, libraries, recreation centers, and other properties can be used to house anyone in need of shelter.

We need a coordinated, local, intergovernmental plan to protect our community, especially vulnerable populations.

- Each of our local units of government should designate a substantial amount of money to be used collectively to address the community's health and economic needs during and after the COVID-19 crisis.
- Each of our local units of government must leverage their power to advance policies, practices and decisions that protect residents, with our most vulnerable at the center.
- Each of the local units of government must direct their resources (staff, facilities, etc) towards meeting the emerging needs of the community.

You are the ones with the resources, the taxpayer funds, and the responsibility to make this happen.

I am proud to live in Illinois under Governor JB Pritzker, who I believe history will smile on. What makes Governor Pritzker stand out as a leader amidst this crisis is his willingness to act *boldly* and *fast*, rather than waiting for his citizens to do (or not do) the work on their own.
