### **7. General Updates of BPD (Wellness Program, Awards, etc.)**

Police in the process of PT testing. Tested approximately 50 individuals. 28 have passed. Those who passed include 2 African-American males and 4 or 5 females with at least 2 other minorities. 24 individuals are scheduled for the upcoming PT test. Chief Wamsley's goal is to have a March 2021 academy with the individuals who passed the testing. 2 officers graduated from the academy in December 2020.

### **8. Strategy update for community listening meetings on police policies and NIOT**

Mr. Taylor and Dr. Black have scheduled a meeting with Mike Matejka Wednesday January 13, 2021 where they will work on the survey language. The plan is to have the survey available in February. The survey will also be posted on the City's website. The PSCRB will call a special meeting to review the results of the survey.

Council Memo and Ordinance Amendment have been completed and submitted. They will appear on the February 8, 2021 Council Agenda.
