This meeting was conducted under Governor Pritzker's Executive Order 2020-07, Section 6, which was reissued and extended by Executive Order 2021-04, and implemented in response to COVID-19, which suspended in-person attendance under the Open Meeting Act, 5 ILCS 120.

The Liquor Commission convened in regular session virtually via Zoom conferencing with Lindsey Meister, Liquor Commissioner, and Amanda Mohan, Deputy City Clerk, in-person in City Hall's Council Chambers and virtually via Zoom conferencing at 4:01 p.m., on Tuesday, February 9, 2021. The meeting was called to order by Commissioner Tari Renner.

Public Comment

Commissioner Renner opened the meeting to receive public comment. Amanda Mohan, Deputy City Clerk, informed the Commission that no individuals had registered speak live and no emailed public comment was received.

Commissioner Renner asked George Boyle, Asst. Corporation Counsel, for a statement in regard to the violations on the agenda.

The following item was presented:

Agenda Item 5. Hearing: First appearance on a Complaint and Citation (#2021-001) issued to Hurley Entertainment Group, Inc., d/b/a Spotted Dog Tavern, located at 1504 Morrissey Drive, as requested by the Legal Department.

Mr. Boyle explained that the Citation was for the alleged violation of the Executive Orders that prohibited indoor dining in the first half of January. The establishment admitted and agreed to one violation, which held a fine of \$500 for the first offense.

The following item was presented:

Agenda Item 6. Hearing: First appearance on a Complaint and Citation (#2021-002) issued to Richards Services, Inc., d/b/a Parkview Inn, located at 1003 S. Morris Ave., as requested by the Legal Department.

Commissioner Renner asked George Boyle, Asst. Corporation Counsel, for an update on the item.

Mr. Boyle informed the Commission that the Citation was for the alleged violation of the Executive Orders that prohibited indoor dining. The establishment admitted and agreed to the violation and paid a fine of \$800 for their second offense.

Rick McCormick, Owner of Parkview Inn, was present but had no comment.

Mr. Boyle explained that the next five citations were for non-payment of food and beverage taxes and that four licensees had reached out to the City and resolved their cases. He stated that Drifters had not and discussed first appearance on citations procedures with Commissioner Renner.

The following item was presented:

Agenda Item 7. Hearing: First appearance on a Complaint and Citation (#2021-003) issued to Hurley Consolidated Enterprises, LLC, d/b/a Drifters, located at 612 N. Main St., as requested by the Legal Department.

Commissioner Renner asked Tanya Minniefield, Owner of Drifters, to address the Commission.

Mr. Boyle stated procedure dictated that staff work through an attorney on these matters and asked Ms. Minniefield if she had attorney representation.

Ms. Minniefield stated their attorney would not represent them in this matter and accepted the violation.

Commissioner Renner confirmed with Ms. Minniefield that she stipulated to the facts. Ms. Minniefield responded affirmatively.

Commissioner Renner and Mr. Boyle discussed the procedure after a first appearance.

Commissioner Renner determined that the item would be continued to the March 9, 2021 Liquor Commission meeting unless a sanctions agreement could be executed before the meeting.

Neither Commissioners Jordan nor Meister had any objections to the decision.

Mr. Boyle explained that the following establishments had made a full payment of the taxes, interest, and penalties in addition to a \$600 fine for their first offenses.

Commissioner Renner explained that the amounts owed were funds that were collected from customers that were to be forwarded to the City.

Mr. Boyle elaborated on Commissioner Renner's statement, and explained that food and beverages taxes were acquired by the licensee at the point of sale from their customers which were then to be remitted to the City. He noted that before a licensee appears before the Liquor Commission, the establishment received several notices and staff attempt to work with the establishments.
