## Two in Custody for October Homicide; One Suspect Still at Large

**Bloomington, IL** - On Wednesday afternoon, 3/31/2021, members of the US Marshals Fugitive Task Force arrested Kevon Moon, 22, of Chicago, Illinois in Lafayette, Indiana for his McLean County murder warrants related to the murder of Jaleel Johnson that occurred in October of 2020. The bond listed on the warrants is \$3 million, 10% to apply. Kevon Moon is being held at the Tippecanoe County, Indiana jail awaiting extradition to McLean County.

Malcom J. Johnson, 27, of Riverdale, Illinois was also served his McLean County murder warrants for the murder of Jaleel Johnson. Malcom Johnson was served yesterday while he was at the McLean County jail for an unrelated arrest. The bond listed on the warrants is \$3 million, 10% to apply. Malcom Johnson is still being held at the McLean County Jail.

## Three shot; one dead in shooting on Bloomington's west side

**Bloomington, IL** - On Monday, October 12th, 2020 at approximately 3:30 p.m., Bloomington officers were dispatched to a report of "shots fired" in the 1600 block of Iowa St. Officers responded shortly after the call for service and located two victims of the shooting. Officers rendered first aid to the victims until Bloomington Fire Department arrived.

The Bloomington Fire Department transported one 20-year-old male to St. Joseph's Medical Center, and one 22 year-old male to Carle BroMenn Medical Center. Officers were also notified that a 27-year-old male had walked in to Carle BroMenn Medical Center with injuries consistent with a gunshot wound. The 22-year-old male victim was transported from Carle BroMenn to Carle Hospital in Champaign/Urbana for his injuries. At that time, all three victims were considered to have sustained serious injuries as a result of the shooting.

At this time, the circumstances behind the shooting is under investigation. Suspect(s) information is not being released at this time. There were no other reported injuries. No arrests have been made.

At 4:31 p.m., McLean County Coroner Dr. Kathleen Yoder pronounced the victim, identified as Jaleel D. Johnson, 20, of Bloomington deceased at St. Joseph's Medical Center.

The 27-year-old and the 22-year-old are still considered in critical condition.
