The total Part I Uniform Crime Report (UCR) statistics for calendar year 2020 was 14.1% lower than 2019, representing 211 fewer reported incidents.



Homicides in 2020


- We recorded 1 homicide in 2020.

 The October shooting of two men in the 1600 block of Iowa Street.
 Two arrests have been made. A third suspect is currently wanted.
- The single homicide in 2019 is closed with three arrests (two convicted so far).
- All homicide cases from 2018, save one, are closed by arrests/convictions.
 The remaining homicide on Oak St. is slated for trial this year.




Shootings

- We recorded 27 shootings in 2020, down from 33 in 2019.
- Most shootings arise from personal conflicts where one or more parties are armed during the confrontations.
- Culture of youth gun possession remains problematic.




Robbery in 2020

- We dropped from 57 robberies in 2019 to 23 robberies in 2020.
- Much of last year's increase was due to social media marketplace sale robberies.
- COVID-19 influenced 2020's totals.



DUI Arrests in 2020

- We arrested 95 fewer intoxicated drivers than in 2019.
- Given COVID-19's impact on drinking establishments, our total for DUI arrests in 2020 is just under the five-year average of 267 DUIs.
- DUI enforcement remains a high priority at BPD.



Domestic Violence in 2020

- Last year we anticipated a slight increase in domestic reports due to COVID-19.
- Domestic Batteries increased by 9.6%
 - This was in-line with a national increase of 8.1% (study of Domestic Violence by National Commission on COVID-19 and Criminal Justice).

Youth Crime Prevention Efforts

- Launch: In March 2019, BPD created framework for a conflict resolution program that supports local at-risk youth, 11 to 19 years of age.
 - Funding awarded to City Life program for service delivery.
 - Programs include mentoring, leadership skills, employment and conflict resolution.
 - Clients also engage with School Resource Officers acting in conjunction with school staff and City Life staff.
- Cost to PD: \$17,500 for programming and \$2,500 for camps/events.
- **Results**: 36 local youth were provided mentoring, tutoring, group meetings, educational material support, recreation and E-Learning.



2021 Departmental Goals

- Post COVID-19, re-engage citizens, community groups and neighborhood associations.
 - Until then, continue to engage citizens through social media platforms.
- Expand the department's new transparency portal:

2021 Departmental Goals

- Develop technologies that support field-based mobile data submission and access.
- Begin planning for replacement of the department's aging Records Management System (RMS). The current system dates to 1998.
 - All agencies transitioned to National Incident-Based Reporting System (NIBRS), January 1, 2021.
- Maintain a system-wide approach to reduction of illegal weapons possession, street level gun violence and gang crimes.
