TAX LEVY DEFINITIONS – TAX EXAMPLE

- Tax Levy: The total dollar amount in real estate taxes adopted by each taxing body.
- Tax Rate: The tax levy (<u>i.e.</u> dollar amount) divided by the total equalized assessed valuation.
- Equalized Assessed Valuation (EAV): Essentially, this is one third of the fully assessed value of the property.

```
Tax Example:
House Value $ 165,000

EAV $ 55,000 (one third of value)

City-BPL Tax Rate 1.4008%

Tax $ 770.43
```

2021 TAX LEVY - KEY NOTES

EAV Related Levy Increase

City: \$275K (no increase to rate)

Library: \$ 50K (no increase to rate)

(Last 12 month inflation = +5%)



2021 TAX LEVY - KEY NOTES (cont.)

Library Expansion Related Increase

Library: \$1.1M (bond debt service)

(Expansion \$17M Bond)
(Increase in tax rate of .0538%)


