## Homicide Victim Identified

**Bloomington, IL** - McLean County Coroner Dr. Kathleen Yoder identified Monday's homicide victim as Timothy Q. Manns, 29, of Bloomington, Illinois. Manns was pronounced deceased by the Coroner's office at 8:45 p.m. on Monday, January 24, 2022. Preliminary autopsy opinion indicates that Manns died from a gunshot wound. Toxicology testing is pending. This incident remains under investigation by the McLean County Coroner's Office and the Bloomington Police Department.

## Homicide Investigation

**Bloomington, IL** - On Monday, 1/24/2022, at approximately 7:30 p.m., Bloomington police officers were dispatched to the 600 block of W. Jefferson St. for a person who had been shot.

Upon arrival, officers located a 29-year-old male victim in an apartment with injuries consistent with a gunshot wound. At 8:45 p.m., McLean County Coroner Dr. Kathleen Yoder responded to the scene and pronounced the gunshot victim deceased. Identification of the victim will not be released until the next of kin is notified.

Bloomington Police Department's Crime Scene Investigation (CSI) detectives and Criminal Investigations Division (CID) detectives were also called to process and investigate the homicide. At this time, there have been no arrests made, no suspect(s) information to release, and there are no other injuries to report. The circumstances regarding the homicide are still under investigation.

Chief of Police Jamal Simington said, "*I am saddened by this unnecessary loss of life and I send my condolences to the victim's family. If anyone has information related to this senseless act or any other, please reach out to us. As always, we need your help to keep our community safe.*"
