## *Unlawful Possession of a Weapon*

**Bloomington, IL** On Monday, 05/16/22, at approximately 02:26 A.M., Bloomington Police officers, attempted a pedestrian stop near the intersection of Morris Avenue and Market Street. The male pedestrian fled while grasping a fanny pack. A short time later, the male was located. Once located, the male resisted officers. The male was taken into custody without injuries. During the arrest, officers located ammunition and a "ghost gun" which are typically a gun without a serial number. There are no enhanced penalties in Illinois for possessing a "ghost gun." The male was identified as Nicholas Mull.

Arrested was Nicholas Mull, 23, of Bloomington, Illinois for:

- UNLAWFUL USE OF WEAPONS / FELON POSSESS / USE WEAPON / FIREARM
- UNLAWFUL USE OF WEAPONS / PERSON
- RESISTING / OBSTRUCTING / PEACE OFFICER / CORRECTION EMPLOYEE
- UNLAWFUL USE OF WEAPONS / CARRY / POSSESS CONCEALED GUN \
