

John M. Scott Heath Care Trust FY2024 Grant Application Scoring Criteria

Category II-Program (100 Points Total)

1. Project Summary (15 Points)

- The executive summary is clear and effectively addresses the purpose of the project/program, the target audience, and intended health outcome. The applicant clearly demonstrates how the project will positively impact the entire community.

2. Project or Program Proposal (50 Points)

- The applicant effectively outlines how this project/program will address the root cause of the problem it is intended to mitigate or solve and adequately justifies the need for funding. The applicant demonstrates a clear understanding of health equity and the Social Determinants of Health. The applicant clearly shows the organization currently has the capacity or will grow capacity using the grant funding to support the project/program. For joint applicants, a clear plan on how responsibilities and resources will be shared was outlined. A clear understanding of the Trust's legal requirements for service and a plan to ensure funding meets these requirements is outlined.

3. Budget (15 Points)

- The project/program budget shows adequate funding for the program to ensure its operation throughout the funding agreement. A clear plan is in place if the organization does not receive all the requested funding. A clear understanding of how the Trust's funding will supplement additional funding sources is evident. The budget demonstrates an efficient cost per unduplicated beneficiary.

4. Evaluation (15 Points)

- The organization clearly demonstrates measurable and meaningful quantitative and qualitative outcomes they will use to track performance of the project/program. The organization has new evaluation tools ready or already in place to evaluate performance.

5. Diversity (5 Points)

- Organizations with a board of directors that is comprised of <25% BIPOC members will receive 0 points. Organizations with a board of directors that is comprised of ≥25% BIPOC members will receive 5 points.

Category II-Capital (100 Points Total)

1. Project Summary (15 Points)

- The executive summary is clear and effectively addresses the purpose of the capital project, the target audience, and intended health outcome. The applicant clearly demonstrates how the capital project will positively impact the entire community.

2. Capital Proposal (50 Points)

- The applicant effectively outlines how this capital project will address the root cause of the problem it is intended to mitigate or solve and adequately justifies the need for funding. The applicant demonstrates a clear understanding of health equity and the Social Determinants of Health. A clear understanding of the Trust's legal requirements for service and a plan to ensure funding meets these requirements is outlined. Projected construction event dates are reasonable and will result in capital project moving forward in a timely manner.

3. Budget (15 Points)

- The capital project budget shows adequate funding is available to begin construction within a reasonable timeframe. A clear plan is in place if the organization does not receive all the requested funding. A clear understanding of how the Trust's funding will supplement additional funding sources is evident. The budget demonstrates an efficient cost per unduplicated beneficiary.

4. Evaluation Plan (15 Points)

- The organization clearly demonstrates measurable and meaningful quantitative and qualitative outcomes they will use to track performance of the capital project. The organization has new evaluation tools ready or already in place to evaluate performance.

5. Diversity (5 Points)

- Organizations with a board of directors that is comprised of <25% BIPOC members will receive 0 points. Organizations with a board of directors that is comprised of ≥25% BIPOC members will receive 5 points.
