## HOLIDAY WEEKEND INCIDENTS

**Bloomington, IL** - On Wednesday, 11/23/2022, at approximately 5:24 p.m., Bloomington police officers were dispatched to the 1400 Block of West Graham Street, for a shot(s) fired incident. Upon arrival, officers found evidence a shot (s) fired had occurred. During the investigation, a 17-year-old male was arrested for AGGRAVATED DISCHARGE of a FIREARM and RECKLESS DISCHARGE of a FIREARM.

On Thursday, 11/24/22, officers conducted a traffic stop near the intersection Wood Street and Bunn Street. During the stop, the passenger, CHRISTOPHER SIMMONS, fled the scene. After a short foot pursuit, Christopher was placed in custody. An article search was conducted in the immediate area where Christopher had fled. During the article search, a firearm was located. Christopher was arrested for UNLAWFUL USE OF A WEAPON and RESISTING.

On Saturday, 11/26/22, officers conducted a traffic stop in the 900 Block of North Main Street. During the stop, a K-9 officer preformed a free air sniff. After the free air sniff, the vehicle was searched. During the search, a loaded firearm was located inside the vehicle. The driver, RAFIQA SIBLEY was arrested for UNLAWFUL USE OF A WEAPON.

On 11/28/22, at 4:37 a.m., officers were dispatched to a business in the 900 block of Maple Hill Road, for a trespassing incident. Upon arrival, officers learned multiple domestic violence incidents had occurred. Officers developed probable cause for the arrest of TREVOR KELLY. At approximately 8:26 a.m., Trevor barricaded himself in an address on Betty Drive. Officers remained in contact with Trevor, until he exited the residence. Trevor was arrested without incident. Trevor was arrested for:

AGGRAVATED DOMESTIC BATTERY - STRANGULATION FELONY DOMESTIC BATTERY FELONY DOMESTIC BATTERY - GREAT BODILY HARM BATTERY TO AN UNBORN CHILD AGGRAVATED BATTERY - PREGNANT PERSON FELONY HARASSMENT BY TELEPHONE The circumstances behind these incidents are still pending investigation. At this time, there are no injuries to report.


