Complainant was arrested in the Fall of 2021 for trespassing. However, the complaint states that as a student he had a right to be there. He was instructed by the officer to comply with the rules of Illinois Wesleyan University to either wear a mask or leave the premises. The complainant argued that it was his "constitutional right" not to wear a mask and that since he was a student he was also an "owner" of the property. When the student would not comply with the instruction to wear the mask or leave the premises, he was arrested for trespassing.

The complainant was convicted of trespassing on 5/9/2022. The complaint he filed against the police was for false arrest, when in fact he was arrested for trespassing. He claimed false arrest and asked that the issue to be reviewed by the PSCRB. The PSCRB is charged with reviewing the actions of the BPD in terms of whether any policy was violated while doing their due diligence looking into the complaint, and taking the appropriate subsequent action. His conviction substantiated the fact that the arrest was in order. The Board agreed that the complaint had no merit. Motion to approve: Ms. Fish. Second: Ms. McFarland.

The Board reviewed the citizen complaints, none of which had been referred to the PSCRB at this time.
