Person Struck by Vehicle

Bloomington, IL - On Thursday, 11/30/23, at approximately 2:00 p.m., Bloomington police officers were dispatched to the 600 block of East Locust Street, for a report of person who had been struck by a vehicle. The vehicle left the scene of the crash. Officers arrived a short time later and began their investigation. The victim, a 48-year-old male, was located. Paramedics with the Bloomington Fire Department transported the victim to an area hospital. The victim is currently listed in critical condition.

The driver and suspect vehicle were located approximately 1.5 miles away from the scene. The investigation led to the arrest of the driver.

- Driving under the influence of alcohol
- Driving under the influence of alcohol with a BAC greater than .08
- Driving on a suspended license
- Aggravated reckless driving resulting in bodily harm

- Resisting obstructing a peace officer
