## **Reckless Homicide Arrest**

Bloomington, IL - On Wednesday, 12/27/23, after an investigation by the Bloomington Police Department's Criminal Investigation Division (CID) and the McLean County Accident Reconstruction Team, Kameron Major was indicted on charges related to a crash which resulted in the death of Travaye Clayton.

On Friday, 12/29/23, Kameron Major was arrested on the warrant.

## ARRESTED:

Kameron D. Major, male, 26, of Bloomington

- Reckless homicide involving a motor vehicle
- Attempted obstruction of justice/destroy evidence (3 counts)

Chief Jamal Simington stated, "It is my hope the outcome of this investigation brings some relief to the family. Loss of life is very difficult, and we will continually seek justice on behalf of crime victims."

All suspect(s) are presumed innocent unless proven guilty in the court of law.



Bloomington, IL - On Sunday, 9/24/23, at approximately 3:23 a.m., Bloomington police officers were dispatched to the 1800 block of Springfield Road, for a report of a single vehicle crash with injuries. The driver was seen fleeing from the scene. The Bloomington Fire Department was also dispatched, due to the vehicle reportedly being on fire.

Upon arrival, the vehicle was fully engulfed in flames and needed to be extinguished by the Bloomington Fire Department. After the fire was extinguished, a front seat passenger was located inside the vehicle. The McLean County Coroner's Office and the McLean County Accident Reconstruction Team were called to the scene.

The passenger was pronounced deceased on the scene by the McLean County Coroner's Office.

Officers and a Bloomington Police K-9 Unit began to conduct an evidence search and track. The K-9 Unit located evidence and then directed officers towards a wooded area, several hundred yards from the crash scene. Officers located the driver of the vehicle laying at the base of the tree line.

The driver was transported by Bloomington Fire Department paramedics to a local hospital for injuries sustained in the crash. He was issued the following citations:

- Failure to remain at the scene of a fatal crash
- Aggravated reckless driving
- Improper lane usage
- Failure to reduce speed to avoid an accident

McLean County Coroner Dr. Kathy Yoder is releasing the following information:

Pronounced deceased at the scene on September 24, 2023, was Travaye D. Clayton, age 27, of Bloomington, Illinois. Preliminary autopsy opinion indicates that Mr. Clayton died from inhalation injuries and thermal burns due to an automobile striking a fixed object, reportedly a tree, with post-crash fire, as the passenger in the car. Toxicology testing is pending.

Chief Jamal Simington stated, "We are saddened the crash resulted in a fatality. The BPD will continue a diligent investigation into the cause of this crash. Every user of the highway system deserves safety to be
