Shots Fired Arrest

Bloomington, IL - On Monday, 04/15/24, at approximately 4:42 p.m., Bloomington police officers were dispatched to the 200 block of Reeveston Drive. Several callers reported hearing gunshots in the area. Patrol officers arrived on scene and located evidence of a shots fired incident occurring.

There were no injuries reported as a result of this incident, but property damage to a residence did occur.

The investigation led officers to Normal, IL. Two handguns were located and collected as evidence. Two subjects were arrested as a result of their involvement in this incident. A third subject was arrested during this incident on four unrelated McLean County warrants. The Normal Police Department assisted with this incident.

Arrested:

Sean S. Walker-Harris, male, 23, of Normal

- Aggravated unlawful use of a weapon / carries on person

Ajea J. Porter-Toney, female, 31, of Chicago

- Aggravated unlawful use of a weapon / carries in vehicle
- Unlawful possession of a handgun
- Reckless discharge of a firearm

The men and women of our patrol division worked as a team and with diligence to identify the culprits in this investigation.
