Fatal Traffic Crash

McLean County Coroner Dr. Kathleen Yoder is releasing the following information regarding the fatal traffic crash at the intersection of Center Street and Bissell Street in Bloomington, Illinois on June 11, 2024.

Pronounced deceased on June 11, 2024, at 8:23 a.m., in the Emergency Department at Carle BroMenn Medical Center, was Devin C. Williams, age 28, of Normal, Illinois. The preliminary autopsy opinion indicated that Mr. Williams died from multiple blunt injuries, due to a motorcycle and pickup truck collision, reportedly sustained as the driver and sole occupant of the motorcycle that struck the side of a pickup truck. Toxicology testing is pending.

The circumstances behind this incident are still pending investigation by the McLean County Coroner's Office, the Bloomington Police Department, and the McLean County Accident Reconstruction Team. Anyone with information should contact the Bloomington Police Department at 309-820-8888.

Previous Release	

Bloomington, IL - On Tuesday, 6/11/24, at approximately 7:47 a.m, Bloomington police officers were dispatched to the intersection of Center Street and Bissell Street, for a traffic crash involving a motorcycle and a pickup-truck. Upon arrival, officers observed the crash and began their investigation. Due to the severity of the injuries, the McLean County Accident Reconstruction Team was called to the scene.

The driver of the motorcycle, a twenty-eight-year-old male, was transported to a local hospital where he was later pronounced deceased. An autopsy is pending.
