Arrest Made in Shots Fired Investigation

Bloomington, IL - After an investigation by the Bloomington Police Department Criminal Investigations Division, detectives established probable cause for the arrest of a 16-year-old male. This arrest stemmed from his involvement in a shots fired incident, on 06/05/24, in the 1000 block of West Front Street.

On Tuesday, 06/18/24, the juvenile was arrested by officers from the Bloomington Police Department and troopers from the Illinois State Police. The arrest was made for Aggravated Discharge of a Firearm. The arrestee was later transported to the McLean County Juvenile Detention Center.

Chief Jamal Simington stated, "In keeping with our strategic plan and priorities, the Bloomington Police Department staff sets out to reduce crime and the fear of crime. We are focused to work tirelessly with community members and use effective technology to solve crimes. I applaud the efforts of our staff in this and other crime fighting efforts."

All suspects are presumed innocent unless proven guilty in the court of law.
