Subject: Ameren and Corn Belt Energy Electrical Suppliers

Background:

Ameren and Corn Belt Energy are the electrical distribution suppliers for power for the majority of residents/business, etc. within the corporate limits of the City of Bloomington.

The City of Bloomington pays a monthly rental fee for electrical service to all public street lights to both Ameren and Corn Belt Energy.

Services Provided:

			outstanding light issues.

City Staff has a positive working relationship with Ameren Community Affairs Manager, Tony Wilkins and he has always been responsive to any issues with street lights. As noted in the attached Ameren Report and the report that the City maintains, lights are being repaired within five (5) days of notification to Ameren. Under the Illinois Commerce Commission, municipalities can request a credit from Ameren for bulbs that are not replaced in ten (10) days. The City has not had the opportunity to utilize the credit process. There is no record or knowledge of any bulbs that have not replaced within ten (10) days. Credit cannot be requested for any issues other than a bulb.

Staff will be working with Corn Belt Energy Staff to set up a standard notification process going forward. Currently Cornbelt does not notify City staff once work has completed.

City Electricians:

As of July 16, 2012 there are no outstanding underground repairs to be made by Corn Belt Energy Light. City staff also maintains the lights on Harwood Place, traffic signals and lights above the traffic signals on Veterans Parkway.

Currently Ameren and City staff rely on residents, businesses and/or a city staff to turn in street light outages as they notice them by contacting support staff in the Engineering Division or by contacting the utility company directly.

Staff Conclusions and Recommendations:

- City's records indicate that street lights are being repaired in a timely manner
- There will be instances that Ameren and/or Corn Belt Energy workload may prohibit them from timely repairs; we have seen this during snow/ice storms, power outages, etc.
- Staff will continue to work with both utility companies and residents to ensure that street lights are maintained to the public's satisfaction
