Request of Christopher J. Zimmerman to allow moderate consumption of alcohol at his June 2, 2012 wedding reception to be held at Davis Lodge on Lake Bloomington.

Request of Carly Dennis and Greg Varner to allow moderate consumption of alcohol at their December 1, 2012 wedding reception to be held at Miller Park Pavilion.

Hurley Enterprises, LLC, d/b/a Drifters, located at 612 N. Main currently holding a TAS liquor license which allows the sale of all types of alcohol by the glass for consumption on the premises seven (7) days a week had the corporate name rejected by the Secretary of State's Office due to an existing corporation. The liquor license for Hurley Consolidated Enterprises, LLC f/k/a Hurley Enterprises, LLC, remains in force.

Request from Big Bev, Inc., d/b/a Friar Tuck Beverage, located at 2401 Maloney Dr., currently holding a PAS liquor license which allows the sale of all types packaged alcohol for consumption off the premises seven (7) days a week to extend beer wine and spirit tastings from three (3) hours in length to four (4) hours per tasting.

The application of Arlandria, LCC, d/b/a Reality Bites, located at 414 N Main, currently holding an RAS liquor license which allows the sale of all types of alcohol by the glass for consumption on the premises seven (7) days a week, requesting an O (outdoor) addition to their liquor license.

Request from Pheasant Lanes Family Fun Center, LLC, d/b/a Pheasant Lanes & Kegler's Pub, located at 804 N. Hershey Rd., requesting an RAS liquor license which allows the sale of all types of alcohol by the glass for consumption on the premises seven (7) days a week.

Request from Little India Bloomington & Normal, Inc., d/b/a Little India Restaurant, located at 503 N. Prospect Rd., Suite 103 – 104, requesting an RBS liquor license which would allow the sale of beer and wine only by the glass for consumption on the premises seven (7) days a week.

Initial Violation appearance of Peggy Ann Bateman, d/b/a Diggers Again!, located at 230 E. Front St., currently holding a TAS liquor license which allows the sale of all types of alcohol by the glass for consumption on the premises seven (7) days a week.

Violation of MugShots Bar & Grill, LLC, d/b/a Mugshots Bar & Grill located at 107 W. Front St., currently holding a TAS liquor license which allows the sale of all types of alcohol by the glass for consumption on the premises seven (7) days a week.

Violation of Road Stop Inc., d/b/a Road Stop located at 1513 Morrissey, currently holding a GPBS liquor license which allows the sale of packaged beer and wine for consumption off the premises seven (7) days a week.
