Re: Liquor Commission Hearing of July 14, 2009, located in the Conference Room,

109 E. Olive St.

The application of Ichiban Chinese/Japanese Restaurant, Inc., d/b/a Lucky Garden, located at 706 Eldorado Rd., requesting an RAS liquor license which would allow the sale of all types of alcohol by the glass for consumption on the premises seven (7) days a week.

The application of Highland Park CVS LLC, d/b/a CVS Pharmacy #7017, located at 1130 S. Veterans Parkway requesting a PAS liquor license which would allow the sale of all types of packaged alcohol for consumption off the premises seven (7) days a week.

The request of Big Cheese, Inc., d/b/a Flingers Pizza Co., located at 608 N. Main St., for an RBS liquor license, which allows the sale of beer and wine by the glass for consumption on the premise seven (7) days a week, with the following conditions: 1.) that the Commission advised Mr. Fruin that it reserved the right to vary the sale hours for liquor and/or to impose "T" Tavern rules if Flingers appeared to be operating as a bar; and 2.) that liquor sales cease at 1:00 a.m. on Saturday and Sunday with no consumption after 2:00 a.m. on the same days of the week; to review condition number two (2), and allow liquor sales to cease at 1:45 a.m. on Saturday and Sunday.

The request of GK Wings, Inc., d/b/a Wings, Etc., located at 511 Chancellor, for an RBS liquor license, which allows the sale of beer and wine by the glass for consumption on the premises seven (7) days a week, with the following conditions: 1.) that music not be allowed on the outdoor patio, and 2.) that the Applicant be put on notice that if the Commission determines that Wings, Etc., appears to be operating with a tavern atmosphere, then the establishment would be required to operate under "T" (tavern) rules after certain hours, to allow music indoors from 7:00 p.m. to 10:00 p.m. and remain a restaurant.

Request by Assistant Chief Robert Wall to discuss the conditions placed on Tjolo's Corp, d/b/a Show Me's Restaurant, located at 517 N. Main St., currently holding an RAS liquor license which allows the sale of all types of alcohol by the glass for consumption on the premises seven (7) days a week and Fat Jack's Inc., d/b/a Fat Jack's, located at 507-511 N. Main St., currently holding a TAS liquor license which allows the sale of all types of alcohol by the glass for consumption on the premises seven (7) days a week.

Request by a citizen to discuss noise in the Downtown area regarding KPTS, Inc., d/b/a Six Strings, located at 525 N. Center St., currently holding a TAS liquor license which allows the sale of all types of alcohol by the glass for consumption on the premises seven (7) days a week.

Public Hearing on a proposed text amendment to Chapter 6, Alcoholic Beverages, Section 21 Closing Hours – Sunday Sales.
